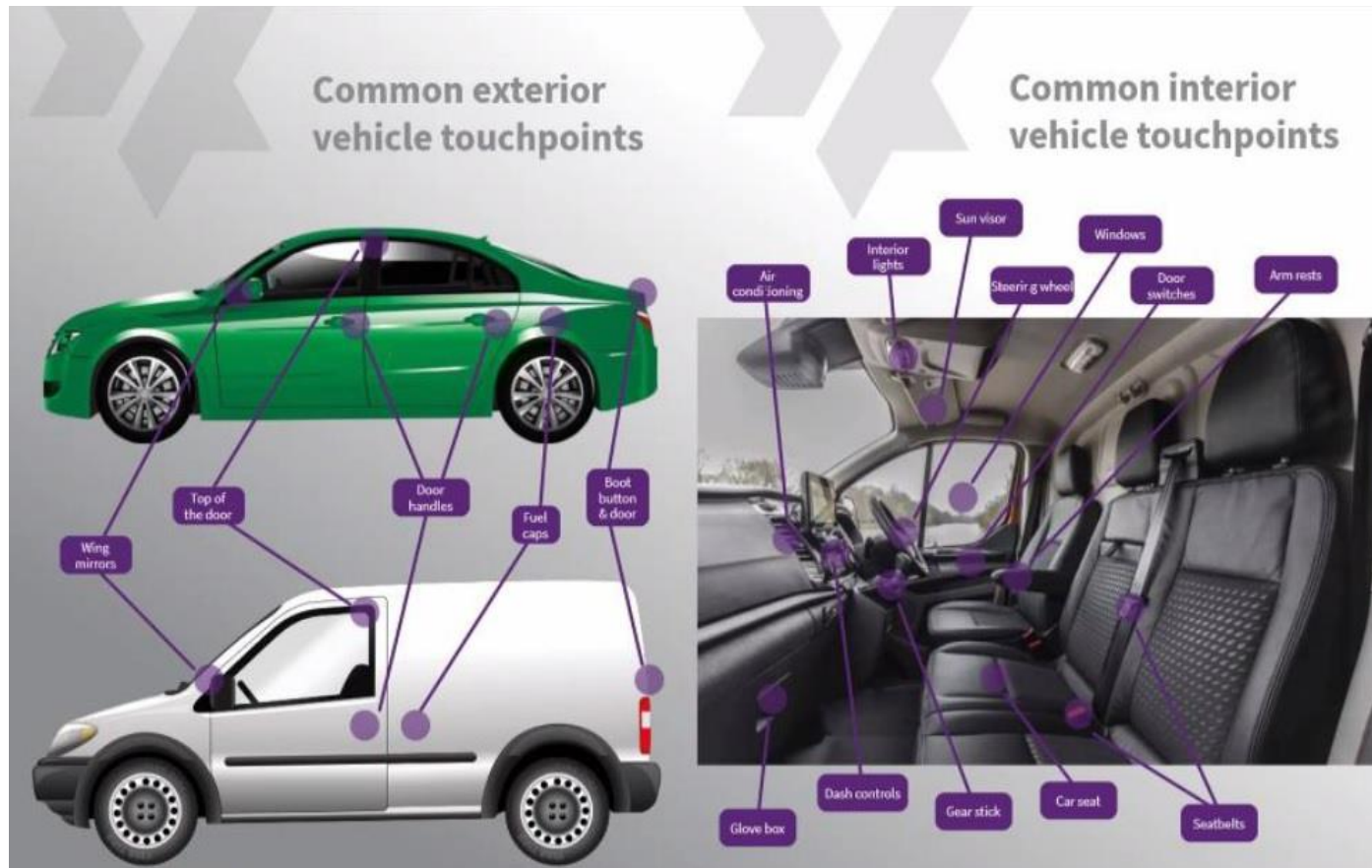


## Additional booking information – Covid-19

### Trainers and trainees meeting Nationally for in car training and in offices / NFE training centre

- Check with trainer / trainee before each training session to ensure they have not been exposed, or are experiencing symptoms which could be related to Covid-19, or have travelled recently from a region severely affected by Covid-19
- Both trainer and trainee will be asked on arrival at the meet location to wash / sanitise their hands before the training session will start
- In these unusual times, you should consider wearing gloves, however you should be aware that some people are allergic to latex based materials, always ask first, facemasks and other PPE is optional and should be provided by trainer / trainee themselves
- If trainer or trainee present for the training session with any clear symptoms, excessive coughing, high temperature etc, either party will refuse the session and another session will be rebooked. If during the session, any of these symptoms present themselves, either party will terminate the training session
